____ **(Option 4)** I/We will make ten monthly payments processed by FACTS Tuition Management on the 5, 15, 20, or last business day of each month beginning August, 2011.

We are enclosing with this completed form the non-refundable registration fee of \$250.00 per student (\$500.00 maximum per family) by April 29, 2011. Beginning May 2, 2011, the fee is \$300.00 per student (\$600.00 maximum per family).

Statement of Tuition and Fees 2011-2012

Each family is asked to meet the full tuition rate for each child if possible.

For those families who are registered, active, and participating members of their parishes, the school allows a reduced tuition rate. The reduced rate will become effective when the tuition agreement form signed by the pastor is received at the school. The reduced tuition rate is not retroactive. Criteria used in determining active and participating membership may vary by parish. Forms for those requesting the reduced rate will be sent to the parish indicated.

Parish approval must be received by Saint Mary's High School no later than July 29, 2011. Forms received after this date will result in the student being charged at the full rate. Transfer students will have 30 days from the date of registration to receive a pastor's approval for the reduced tuition rate.

Financially, the Catholic high school must depend not only on tuition and diocesan grants to meet ever rising instructional and operating costs, but also other fundraising activities. Saint Mary's High School has an established mandatory annual Walk-a-thon fee of \$100.00 per student. This obligation will be charged to your student tuition account at the beginning of the school year. Parents are also encouraged to contribute up to \$1,000.00 to the Catholic Tuition Organization of the Diocese of Phoenix and receive a dollar for dollar tax credit from the State of Arizona (contact the school for more information). These direct and indirect sources of funding will help us continue to meet the cost of educating young men and women in our Diocesan Catholic Schools.

Tuition Payments do not include uniform costs, walk-a-thon fees, registration fees, textbooks, parking fees, graduation fees, or athletic participation fees.

Payment Plans

Option 1: Full Payment is due by August 5, 2011 processed by FACTS Tuition Management.

Option 2: Semi-Annual Payment Plan: Two payments are processed by FACTS Tuition Management. The first payment of one-half of the tuition will be paid on or before August 5, 2011 and the second half will be paid by December 5, 2011 through FACTS Tuition Management.

Option 3: Quarterly Payment Plan: Four payments are processed by FACTS Tuition Management on August 5, 2011, October 5, 2011, January 5, 2012, and March 5, 2012.

Option 4: Ten monthly payments will be processed by FACTS Tuition Management beginning August, 2011.

Tuition payments will be adjusted to reflect financial aid awards granted. Please complete a separate CTODP Financial Aid Application and send it in to the FAIR organization before the April 18, 2011 deadline.
